


Global M2-Wachstum vereinigt die Länder-Geldschöpfung in Lokalwährung und den Dollar-Aussenwert













vs. Wachstum Globales M2 (invers, 6mth fwd)







vs. Wachstum Globales M2








Global M2 yoy (4 Mth Lead)






















Global M2 yoy (5Mth Lead)







vs. Wachstum Globales M2











Emerging Markets Währungen (yoY) vs. Wachstum Globales M2















vs. Wachstum Globales M2








